### 1.16 - Gold Master Release 2.2.1 - January 2021

Gold Master Version 2.2.1 has been officially released to Stemmons' clients on January 2021. This release includes a few enhancements to document/photo gallery viewing. It also added a new key element entity searching capabilities to allow the company identify specific key data search.

Stemmons Central Gold Master version 2.2.1 has been officially released to Stemmons' clients on January 2021. This release includes a few enhancements to document/photo gallery viewing. It also added a new key element entity searching capabilities to allow the company identify specific key data search. Beside the noted new features, this release is scheduled to resolve many prior bugs reported by Stemmons clients.

Below is the list of newly added features and bug fixes:

- 1. Document Viewer: A new column is now available in the Case and Entity grids with a list of downloadable file attachments for each case or entity. This option allows the user to easily accessing the attachments without having to access the case or entity. The list of attachments is also available via a new Document button in the case/entity ribbon.
- 2.**Photo Gallery View**: Next to Document Viewer, if the Entity Type has a Photo Gallery field and the Photo Gallery is shown on the list, the Photo Gallery will be available for user to access directly without having to go to the entity view page via a gallery caruso view.
- 3.**Search**: In this release, we are rebuilding the Search Application with major performance improvements and searching capability.

In addition to **Simple Search** (Google Search) and **Advanced Search** (specific Search); a new search capability "**Key Element Search**" has been implemented.

**Key Element Search** is an Entity Search that can be custom defined for the organization to help finding the specific key data for the business much quicker. For example: in Real Estate, key data elements could be defined as Property and Tenant Search. In Retail, it could be Product and Customer Search, etc. Once defined, Key Element Search options will be accessible via the Homepage to help the users to effectively find the specific data easier and faster without having to go through multiple steps.

Once the key entity type is defined via Key Element Search, the system will allow the user to find the data along with its relationship and role assignment as defined by the administrator.

4.Put back option to open Cases or Entities via a popup window. This is now a configuration item. The organization can decide to have the case or entity item opens in a new tab or via a popup window.

# **5.Cases Application Enhancements and Bug Fixes**:

- Case Activity Log is now captured and logged field updates
- Case Import Tool: allows file attachment to be uploaded along with the cases during the import
- Case Portal: allows External Users to assign cases to the internal users who have worked on or viewed the case (list of users from Activity Log)

- Improved lazy loading in case notes
- Resolved issues with Export to Excel on large volume case list
